Commissioner Folkvord moved to approve payroll for pay date 12/31/2020 in the amount of \$190,807.88, and to approve minutes dated 1/4/2021. Motions seconded by Commissioner Randolph and carried.

Commissioner update: Commissioner Delger reported they are working with Bridger Brewery to navigate the bonds process. Commissioner Folkvord said donated art work may soon be displayed in the meeting room. Silos master plan and LAC meetings are scheduled this week.

Commissioner Folkvord moved to adopt and ratify the Broadwater County Commissioner Meeting Agenda and Open Meeting Policy. Comment from Cory Swanson, County Attorney. Motion seconded by Commissioner Randolph and carried.

Commissioners reviewed the format of the contract for Trust Board secretary.

After review of the job description and salary matrix for the salary increase request for Administrative Assistant for Public Heath Nurse, Commissioner Randolph moved to grant a \$.60/ hour increase in salary. Motion seconded by Commissioner Folkvord and carried.

Nichole Brown, Community Development, presented the County Board Membership Practice for review. Commissioner Folkvord moved to add "Board positions may be limited to 2 terms." and to amend "renewing board members <u>may</u> be vetted by existing board." Motion seconded by Commissioner Randolph and carried.
