December 20, 2021

Commissioner Mike Delger called the meeting to order at 10:00 a.m., Commissioners Darrel Folkvord and Debi Randolph were also present.

Public Comment: None.

Nichole Brown, Community Development Director presented Schoer Boundary Relocation Request. Commissioner Randolph moved to approve aggregate and boundary relocation of the lots in COS. Motion seconded by Commissioner Folkvord and carried.

Nichole Brown presented Benyo Boundary Relocation Request Community. Commissioner Randolph moved to approve Benyo boundary relocation. Motion seconded by Commissioner Folkvord and carried.

Nichole Brown discussed Planning Board Appointments Jeanine Stone and Deanna Kolodka. One Planning Board member resigned and there are two vacancies. Commissioner Randolph moved to approve Jeanine Stone and Deanna Kolodka for Planning Board for three-year terms beginning first week of January. Motion seconded by Commissioner Folkvord and carried.

Josh Obert, Public Works presented City/County Snow Removal Usage Agreement. Commissioner Randolph, Commissioner Delger, and Jania Hatfield provided commentary concerning 18 inches of snow accumulation. Commissioner Randolph moved to approve Snow Removal Vehicle Usage Agreement. Motion seconded by Commissioner Folkvord and carried.

Commissioner Randolph moved to unappoint Josh Obert, appoint Commissioner Delger and a to-be-named surveyor to conduct the investigation for Ross Gulch Rd. Motion seconded by Commissioner Folkvord and carried.

Josh Obert presented RFP Solid Waste Contract. Commissioner Randolph moved to award Tri County Disposal contract. Motion seconded by Commissioner Folkvord and carried.

Commissioner Randolph moved to approved Nov 29, 2021, and Dec 13, 2021, minutes. Motion seconded by Commissioner Folkvord and carried.

Communications received: Shoer COS, Benyo COS, Snow Removal Vehicle Usage Agreement, Solid Waste RFP Cost Comparison and Evaluation Scoring Sheet, receipts for MT DOR rent \$250 and Family Medical Clinics rent \$1,331.00.

Commissioner Randolph moved to pay approved amount of \$697.50 for Broadwater County Health for Two Brothers Tires Mediation claim. Motion seconded by Commissioner Folkvord and carried.
