

COMMISSIONER MEETING
416 Broadway, Townsend, MT 59644
June 28 2021

Commissioner Mike Delger called the meeting to order at 10:00 a.m., Commissioners Darrel Folkvord and Debi Randolph were also present.

Public comment: Tim Ravndal asked again for consideration of a resolution on 30x30 mandate. Ed Shindoll, Rural Fire Chief, asked about American Recovery Funds for fire, and expressed concern about fireworks due to extreme heat and drought. Fireworks are not allowed on any federal ground.

Nichole Brown, Planning, presented the Headwaters Minor Subdivision for final approval. Commissioner Randolph moved to approve said subdivision. Motion seconded by Commissioner Folkvord and carried.

Nichole presented the O'Hern boundary relocation for consideration. Commissioner Folkvord moved to accept the COS exemption. Motion seconded by Commissioner Randolph and carried.

Cory Swanson, County Attorney, gave a brief overview of concerns about the old Toston bridge. Bill Lane stated the load limit sign on the east side of the bridge is gone, and heavy loads are crossing the bridge. Franklin Slifka wants a 15mph speed limit, and said Sletton/ MDT should repair the bridge. Josh Obert, Public Works, said the sign will be reposted. Cory stated this conversation was for information only.

Commissioner Folkvord moved to appoint Victor Sample and Dawn Langlinais to 3-year terms on the Hospital District Board. Motion seconded by Commissioner Randolph and carried.

Commissioner Randolph moved to sign the DEQ-required zoning compliance for the expansion of Capital Concrete opencut mine near Winston. Motion seconded by Commissioner Folkvord and carried.

Commissioner Randolph moved to sign the DNRC Local Government Forestry Assist Grant for the Big Elk Divide Restoration Committee for travel and record keeping in the amount of \$11,000.00. Motion seconded by Commissioner Folkvord and carried.

Mike Myers, Maintenance, presented the bids for roof repair: North Star Roofing – Detention Center, \$32,900; Search and Rescue, \$38,600. Bent Tree Enterprises – Detention Center, \$76,433.81; Search and Rescue, \$33,194.45.

Commissioner Folkvord moved to approve minutes of the 6/21/2021 meeting. Motion seconded by Commissioner Randolph and carried.

Communications received: notice of House Bill 102 – concealed weapons carry in buildings and state lease. Communications are on file in the Commissioners' office as deemed necessary, and are available for review.

Commissioner Randolph moved to pay approved claims dated 6/23/21 for \$93,170.03. Motion seconded by Commissioner Folkvord and carried.

Jania Hatfield, Bernadette Swenson, Jerry Olson and Helen Coleman were also present.

Commissioners entered into a closed-door session for personnel issue.

The meeting was adjourned at 2:15 p.m. The next regular meeting is scheduled for July 6, 2021, at 10:00 a.m.
