

**COMMISSIONER MEETING**

**May 28, 2019**

Commissioner Mike Delger called the meeting to order at 10:00 a.m. Commissioners Laura Obert and Darrel Folkvord were also present.

Public comment: Debi Randolph asked for the Trust Board to be on the June agenda. Tim Ravndal asked about his request to be appointed to the Planning Board.

Commissioner Obert moved to approve minutes dated 5/20/2019. Motion seconded by Commissioner Folkvord and carried.

Communications received: DEQ notice of wastewater discharge permit for Harlowton and Stockett; US Census Bureau notice of 2020 Census New Construction Program; DHHS result of water tests at Silos Recreation Area; Water & Waste Digest. Communications are filed in the Commissioners' office as deemed necessary and are available for review.

Commissioner Folkvord moved to pay approved claim dated 5/21/19 for \$24,376.99 for purchase of 2017 Chevrolet Colorado by the Mosquito Board. Motion seconded by Commissioner Obert and carried.

Commissioner update: Commissioner Delger attended the LEPC meeting and toured roads. Commissioner Folkvord met with Senator Daines' representative and toured roads. Commissioner Obert attended the National Justice and Public Safety Committee meeting. All commissioners attended the meeting with Bill Jarocki and the Sheriff's department union negotiation meeting.

Commissioner Obert moved to sign the Master Contract from the Montana Department of Public Health and Human Services for the provision of Public Health Services by Broadwater County, effective July 1, 2019 through June 30, 2026. Motion seconded by Commissioner Folkvord and carried.

Doug Ellis, Treasurer/Clerk & Recorder, presented his proposed FY2020 budget. He asked for permission to cancel delinquent personal property and mobile home taxes as required by MCA. Commissioner Obert moved to sign the resolution ordering the cancellation of personal property that have been delinquent for 5 years; and to sign the resolution ordering the cancellation of mobile home taxes that have been delinquent for 5 years. Motions seconded by Commissioner Folkvord and carried.
