Commissioner Darrel Folkvord called the meeting to order at 10:00 a.m., Commissioners Mike Delger and Debi Randolph were also present.

Public comment none.

Nick Rauser, Sheriff Office Captain presented Tek 84 Body Scanner for the jail to X-ray inmates' body to detect anything illegal on or in the body, for security purposes, and for avoiding lawsuits pertaining to violations during required body searches. Is requesting money from COVID relief funds of the \$132,900.00. Dan O'Mally, former officer in narcotics in Lewis & Clark Co. and now works for MACO. Drugs are hidden inside females and males. Also, takes a picture of the inmate for booking photo. Jania Hatfield, County Attorney's Office, and Brandon Harris, Undersheriff, offered comments.

Esther Fishbaugh, concessionaire at Silos Marina and Campground presented County Silos Funds to Canyon Enterprises. Liability risk if floats are not replaced. \$3,000-5,000 would keep in good repair each year, plus labor. Sometimes it is best to go out and accomplish repairs while the water is low. Already put in \$40,000 to repair. Add to the agenda February 7, 2022, for final decision.

Commissioner Delger moved to approve Interlocal Agreement to Appoint Special Deputy County Attorney from the Lewis and Clark County Attorney Office. Seconded by Commissioner Randolph and carried.

Jania Hatfield, presented Time Clock Contract for payroll. Will be discussed again after meeting recess.

Commissioner Randolph moved to approve claims in the amount of \$171,837.27. Seconded by Commissioner Delger and carried.
