PROCEEDINGS OF THE BOARD OF COMMISSIONERS BROADWATER COUNTY, STATE OF MONTANA

Commissioner Darrel Folkvord called the meeting to order at 10:00 a.m. Commissioners Mike Delger and Debi Randolph were also present.

County Attorney Jania Hatfield presented Montana Distributors and Janssen Opioids Settlement Memorandum of Understanding. Commissioner Randolph moved to approved signing MOU. Commissioner Delger seconded and carried.

Horse Creek Hills Subdivision

- Broadwater County Community Planner Nichole Brown presented updated Feb 17, 2022, Staff Report. Hatfield presented MEMO re: Information Regarding Water Usage and Exempt, Second Addendum to Horse Creek Hills Major Subdivision Staff Report New Information. Hatfield offered comments. County Sanitarian Shawn Rowland offered comments regarding water, waste water, storm water and solid waste. Lot 41 is the specific lot reviewed locally by Rowland. Director Obert offered comments.
- Mark Fasting with Allied Engineering represented the applicant/Subdivider and presented for 71 Ranch LP.

Commissioner Delger requested how to substitute for Dundas water shortage in the event the Subdivision takes water from the Dundas land. Fasting commented that it would depend on the hydrogeology evaluation. Director Obert offered comments on mag chloride on the roads. Commissioner Folkvord requested that the developer be willing to put up a fence. Attorney Coyle said that would likely be acceptable. Folkvord also requested the builder put up a cattle pass. Toby Dundas offered comments discussed collecting snow on the side of the road. Director Obert responded. Discussion tabled to July 11, 2022.
