Commissioner Darrel Folkvord called the meeting to order at 10:00 a.m. Commissioners Mike Delger and Debi Randolph were also present.

Public comment: none.

Correction on article that was released in Broadwater County News that the proposed new county subdivision fees have not been approved or adopted at this point.

The Old Toston Bridge has been closed by the State of Montana.

Commissioner Randolph moved to approve claims in the amount of \$29,111.57. Commissioner Delger seconded and carried.

Commissioner Delger moved to approve claims in the amount of \$121,076.19. Commissioner Randolph seconded and carried.
