

**COMMISSIONER MEETING**

Commissioner Darrel Folkvord called the meeting to order at 10:00 a.m., Commissioners Mike Delger and Debi Randolph were also present.

Commissioner Randolph moved to approve with suggested changes by Jania Hatfield, Acting County Attorney. Commissioner Delger seconded and carried. Commissioner Delger seconded the amended motion and carried.
