10:42 AM Broadwater County Public Works Director TJ Graveley presented Purchase of Fast-12T Radar Speed Trailer Request in the amount of \$9,300.00 and will partner with the Sheriff's Office and split the cost of purchasing this speed trailer. Speeding on several roads in the south end of the county is concerning. Commissioner Richtmyer moved to approve the Fast-12T Radar Speed Trailer, which the cost of \$9,300.00 will be split in half with the Sheriff's Office. Commissioner Randolph seconded and carried.

10:49 AM Director Graveley gave an update on roads and solid waste across the County. The walk-in can in Winston will be closed. Starting on October 10, 2023, the Winston Canister Site will be open on Tuesday and Thursday from 2 p.m. - 6 p.m., which could be subject to change because there are not lights at this location. Also, Goose Bay has been grated. Copper City, which is not a county road, is currently closed for construction due to rerouting the road. 10:55 AM Director Graveley gave an update on bridges.

10:15 AM Broadwater Deputy County Attorney presented Newspaper RFP (Request for Proposal). Montana Code Annotated section 8-7-413 requires a bid to become a legal paper of record if there is more than one qualified local newspaper within the County. Maximum length of the contract up to two years and this will end June 30, 2025. Bids will be delivered in a sealed
