Vice Chair Roger Flynn called the meeting to order at 4:24 p.m.

Vice Chair Roger Flynn, Members Joe Gill, Adam Six, and Spencer Sellay were present. Chairman Vic Sample was present via phone. Commissioner Lindsey Richtmyer was also present.

Joe Gill moved to approve the October 12, 2023 minutes. Spencer Sellay seconded and it was carried

The board discussed what a third-party partnership would look like without having a conflict of interest. The board had questions about what the cost would have to be in order to go through the RFP (Request for Proposal) process. It was also discussed if a different entity besides the county could hire that "third party". A third party could ultimately help with a feasibility study, help connect with providers, and look out for the county's best interest.

Commissioner Richtmyer had talked with Dean Nelson prior to this meeting. The discussion was that a number of people were going away from the BEAD grant process due to it being too complicated, the scoring rubric was not necessarily great, and the hardship of coming up with a 25 percent match. Connect 5 grant will be opening up in December.

The other part of the discussion pertains to Starlink. With the rounds of bids expected for BEAD funding, any area that does not have any bids potentially could be covered by Starlink (Satellite). The possibility for funds to go to a satellite company versus a local (Montana) company could be a setback for Broadwater County.

With the different discussions, the board will try to set up a time for different individuals to come and talk with the board including BDCD, Montana Internet, Dean Nelson, and Tory Richtmyer. These conversations would be information gathering only.

The board members are in contact with VisionNet and Vigilante Electric. There has been no communication with the other providers.

The board discussed since the CAC meetings are being a bit more direct with their information, that perhaps a CAC review meeting is not necessary. The next CAC meeting is Tuesday, November 7<sup>th</sup> in Helena, Montana

The board will work on contacting the individuals/companies that they wish to speak with and setting up those discussions. The next regular meeting has been scheduled for November 30, 2023 at 4:00 pm at the Flynn Building.
