## FY2020/2021 BUDGET APPROVAL

## RESOLUTION 2020-\_\_\_

**WHEREAS**, 15-10-203, MCA, requires the County to "hold a public hearing for the purpose of receiving comments on its intention to budget increased property tax revenue, and to advertise its intent to budget increased property tax revenue, and

**WHEREAS,** Pursuant to Section 7-6-4024, MCA, the Board of Commissioners of Broadwater County, Townsend Montana, held a public hearing on the proposed budget of Broadwater County for fiscal year 2021 as required by law.

**WHEREAS,** 15-10-420, MCA, Impose a mill ley sufficient to generate the amount of property taxes actually asses in the prior year on previously existing property plus one-half of the average rate of inflation for the prior 3 years; and allows the County to carry forward its levy authority even if it did not levy the maximum authorized in a prior year; and

**WHEREAS,** 15-10-420 AND 2-9-212 MCA, allows the County to levy for group benefit premium increases; and to levy for any decrease in reimbursements; and

**NOW THEREFORE, IT IS HEREBY RESOLVED**, by the Broadwater of County Commissioners that the budget be approved and adopted and that warrants be issued in accordance with the laws appertaining thereto.

**IT IS HERBY MOVED, SECONDED AND CARRIED** by the Board of County Commissioners that the resolution be adopted for fiscal year end 2020(attachment A) with the caveat that the Three Forks and Townsend Schools be added later when received; and

**WHEREAS,** the above resolution adopting the budget was passed by the Board of County Commissioners, and

**WHEREAS**, Sections 7-6-4034 through 7-6-4036, MCA, provides for the determination of and the fixing of various tax levies to raise funds sufficient to meet said expenditures authorized in the budget.

**WHEREAS**, Section 7-4-2504, provides that the salaries of the elected officials be set by resolution as proposed by the County Compensation Board ,and approved by the Board of County Commissioners, and be included in the expenditures as authorized in the budget.

**NOW THEREFORE, IT IS HEREBY RESOLVED**, that the salaries for each of the elected officials is established and set out in the attached for fiscal year end 2021(attachment C); and market adjustment requests authorized at 50% in this fiscal year end 2021 and the remaining 50% in fiscal year end 2022

**WHEREAS**, the Department of Revenue is required to certify to the County Commissioners the value of a mill for each taxing jurisdiction in the County under Section 15-10-5202 MCA; and

**WHEREAS**, the value of a mill County wide, is \$18,575.73 the county wide taxable valuation is \$18,575,728, and

**NOW THEREFORE, BE IT RESOLVED** that the final County Budget is set out in the attached (attachment B), by this Board of County Commissioners that the levies as detailed in the attachment be fixed and adopted for fiscal year end 2021
