Dear Commissioners:

This letter constitutes *Task Order No. 8* to our *Agreement for Professional Services* dated November 4, 2020, for the above-referenced Project. Great West's scope of services, schedule of fees, and schedule for completion of these services ("Services") are as follows:

**Great West Engineering's scope of services under this task order is to assist Broadwater County in submitting a Federal Lands Access Program (FLAP) project application to fund improvements to the Goose Bay Road. The scope and services will include the following:**

- **Great West will review road repair recommendations provided by the County. A site visit will occur to finalize repair recommendations and document road conditions for the FLAP application. An engineer's opinion of probable cost for the road improvement options will be prepared.**
- **Prepare a GIS map to show scope of improvements and extent of project in relation to federal land.**
- **Coordinate with Broadwater County and federal agencies through phone or virtual calls to discuss the project and FLAP application. The intent of the coordination is to gather information for the FLAP application and discuss scope of improvements with federal agencies.**
- **Great West will develop narratives for the FLAP application. The previously submitted 2016 grant application narratives will serve as the basis for the new application.**
- **Update documentation of environmental impacts as it relates to the FLAP application. The preparation of a full Environmental Assessment (EA) is NOT included in this scope of work. Environmental documentation will be obtained through a desktop survey that includes mapping of agency databases. An EA may be prepared during the preliminary design stage of the project by Western Federal Lands.**
- **The County is considering hosting a new public meeting to document support for the project. If a meeting is held Great West will provide hardcopies of GIS maps and cost estimates for the meeting. Attendance by Great West personnel is not included.**

As compensation for these Services, Client shall pay Great West a lump sum amount of \$7,500 as determined by the *Consultant Agreement*. This amount cannot be exceeded without Client's prior written approval.
